CRIMES RECORDED BY POLICE AUTHORITIES IN 2022

The purpose of this document is to briefly present the indicators on crimes recorded by police authorities in 2022, recently released in the online consultation system of Justice Statistics.

In 2022 the number of crimes recorded was 343,845. Of this number, crimes against property stood out, accounting for about 50.7% of the total (174,268 crimes), followed by crimes against persons, which corresponded to about 25.0% of the total (85,841 crimes), and crimes against life in society, which accounted for 12.8% of the total (44,015 crimes) (table 1).

Table 1 - Crimes recorded, by type of crime, in 2022

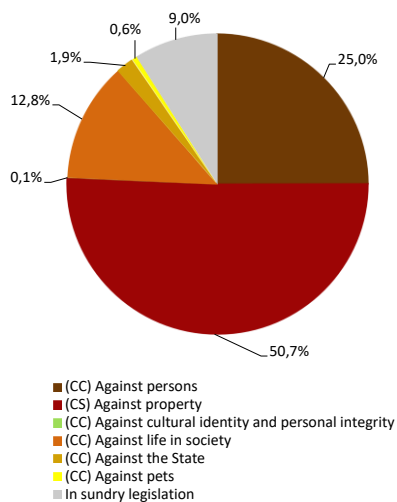
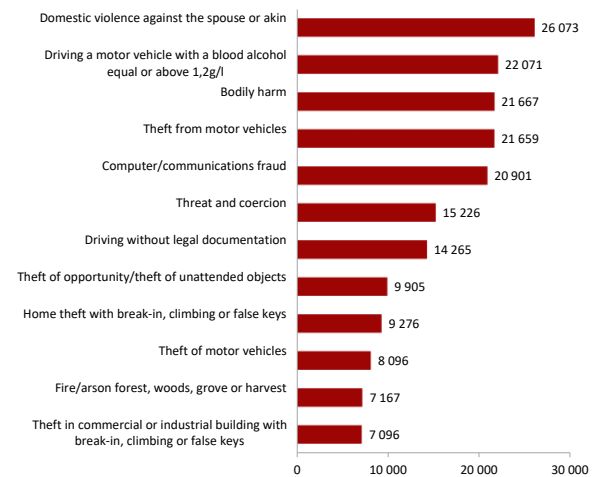


Table 2 highlights some of the most frequent crime categories, among which is the crime of "domestic violence against spouses or akin" with 26,073 crimes and the crime of "driving a motor vehicle with a blood alcohol equal or above 1,2g/l" with 22,071 crimes².

Framework Note

The values presented correspond to the crimes recorded by the following entities: Criminal Police, Public Security Police, National Republican Guard, Economic and Food Safety Authority, Maritime Police, Municipal Police, Military Criminal Police, Immigration and Borders Service and Tributary and Customs Authority.

Technical sheet

The Directorate-General for Justice Policy (DGPJ) of the Ministry of Justice, in accordance with Article 2 (1) of Decree-Law 163/2012 of 31 July, has the mission to give technical support within the scope of legislative production and legal assessment, to monitor the policies and the strategic planning for the sector, to coordinate the external affairs and the cooperation in the justice area, being also responsible for the statistical data in the Ministry of Justice.

Law 22/2008 of 13 May defines the main general guidelines and principles that govern the National Statistical System (SEN), in particular the delegation of powers of the National Statistical Institute IP (INE) in other entities.

Under the provisions of Article 24 of Law 22/2008, of 13 May, a protocol was celebrated empowering DGPJ with the production and dissemination of the Justice official statistics.

As a delegated entity, DGPJ is subject to compliance, in its relevant part, with Law 22/2008 of 13 May, with Decree-Law 166/2007 of 3 May, as well as with the rules established by Community legislation. It adopts the European Statistics Code of Practice and the Regulation for the Application of the Principle of Statistical Confidentiality of INE.
